Subject: Cook Islands Vessels Calling at Ports Identified as High Risk

Summary

In order to reduce the number of detentions being experienced by Cook Islands flagged vessels, Maritime Cook Islands has identified High Risk ports and appointed a Maritime Cook Islands Flag State Inspector at these ports.

Cook Islands vessels calling at these ports **must** notify the following persons in advance of their arrival at the port, by adding them to cc on the port agent communications.

- Technical Director at df@maritimecookislands.com;
- Registrar of Ships at fleet@maritimecookislands.com,
- HO European representative Paolo Favilli at paolo@maritimecookislands.com;
- The responsible Deputy Registrar;

- Maritime Cook Islands appointed Port Flag State Inspector (see above table)

Vessels calling at these ports will be required to undergo a Flag State Inspection, the cost of which will be borne by Maritime Cook Islands.

The Flag State Inspectors aim will be to ensure the vessel is not detained and will not cause undue delay to the vessels. Deficiencies (if any) during the inspection will be required to be entered into the ISM system. A copy of the NCRs and CARs will be, required to be submitted to the Technical Director at df@maritimecookislands.com, Registrar of Ships at fleet@maritimecookislands.com and the responsible Deputy Registrar.

Where a Flag State Inspector, in his or her professional opinion, finds the vessel is unsafe to proceed to sea in other words, is a risk to crew, passengers, cargo, other vessels and / or the marine environment, the vessel will not be permitted to proceed to sea until the identified deficiencies causing the vessel to be unseaworthy are rectified to the satisfaction of the Inspector.
